PREFACE

This publication presents data on the value and volume of trade between The Bahamas and the rest of the world. It contains a five year series of summary data to provide an historical view of trade for The Bahamas during that period. Detailed tables (both annual and quarterly) of the year 2015 are presented in order to provide an in depth view of trade for that year.

Reports on trade statistics for The Bahamas have been published since 1968 and have undergone many revisions in both the format of the report and the methodology of the compilation of the figures. Initially, trade statistics were compiled using the Standard International Trade Classification (SITC), which classifies commodities by two criteria (1) the material of which the commodity has been made and (2) how the commodity will be used. This classification, subjected to periodic revisions, is still used today, though not predominantly.

The Harmonized System (HS) was adopted by the Customs Co-operation Council in June 1983 and enforced by the HS Convention in 1988. In 1993, the United Nations Statistical Commission, at its 27th session recommended that countries adopt the HS for the compilation and dissemination of their international trade statistics. In The Bahamas, however, the Customs Department did not implement the HS until July 1996 and the Department of Statistics followed suit in January, 1997. Since its implementation, the HS has been regularly revised, the latest having occurred in 2012 and implemented in July 2013. As a result the figures in this 2015 report are reflective of the 2012 revision of the HS code.

The data in this report are collected by the Bahamas Customs Department and are forwarded to the Department of Statistics where they are processed, analyzed and published. Both the SITC and the HS system of commodity classification are used in the presentation of the data.

Data Notes and Explanation

1. Data Source

The source documents of the statistics in this report are the Customs import entries, declarations and export documents submitted by importers and exporters, which are subject to verification and approval by The Bahamas Customs Department.

2. Coverage

As recommended by the United Nations International 'Merchandise Trade Statistics Manual', and to the extent possible, the General Trade System is used for the recording and compilation of external trade statistics for The Bahamas. This system covers all types of inward and outward movement of goods through a country or territory, including movements through warehouses and free zones. In essence, it includes all merchandise that either add to or reduce the stock of material resources of a country or territory by entering (imports) or leaving (exports) the country's economic territory.

3. Transaction Values

The value of imports are c.i.f., that is, the value at the port of importation including freight and insurance charges and other charges incidental to the delivery at the port of import.

The values of exports are f.o.b., that is, the value of goods including the cost of transportation and insurance to the border of the exporting country.

The values presented are Bahamian dollars and the exchange rates prevailing at the time of importation are used in converting foreign currencies.

4. Changes/Exclusion to Presentation of Trade Data

Excluded from the compilation of the foreign trade statistics are the goods traded that do not make any changes to the wealth and material resources of the country. Examples of such goods are crude oil, residual fuel oils and certain chemicals temporarily imported for storage purposes only.

5. Commodity Classification

The classifications of goods used in this report are the Harmonized Description and Coding System, better known as the Harmonized System (HS) and the Standard International Trade Classification (SITC). The HS arranges goods according to their degree of manufacture and classifies them into ninety-seven chapters which are grouped into twenty-one sections. Section twenty-two was added to accommodate local trade. The SITC on the other hand, arranges goods according to their stage of production. The SITC contains sixty-seven divisions which are condensed into ten sections.

Definitions and Abbreviations:

Imports – Goods imported from foreign countries for further processing or local consumption.

Domestic Exports – Goods produced or manufactured locally and exported to foreign countries.

Re-exports – goods exported in the same condition as when imported from a foreign country

Balance of Trade – is the total export minus the total import. It is usually calculated totally for a country or for each trading partner.

Port of Entry – a port that serves as a first port of entry from an international port.

2015 Annual Trade Data Highlights

Data on merchandise trade for the year 2015 show that the value of commodities imported into The Bahamas totaled \$3.2 billion resulting in a significant decrease of 16.5% between 2014/2015.

As it relates to major groups of merchandise, the category of 'Machinery and Transport Equipment' which totaled \$614.6 million accounted for 19.4% of the imports. This was followed closely by 'Mineral Fuels' which was the largest contributor to goods imported in 2014 and now totals some \$535.3 million (16.9% of all imports) for 2015. (Chart 1)

Other major contributors to imports were the categories of **'Food and Live Animals'** category (fresh meats, fruits & vegetables and processed foods) which totaled \$508.7 million representing 16.1% of total imports and **'Manufactured Goods'** which accounted for 13.6% of total imports with a total of \$432.9 million and the **(Chart 1)**

The commodities which contributed mainly to total imports were, 'Motor Gasoline (Unleaded)' valued at \$197.4 million, 'Diesel' valued at \$157.8 million, 'Other Lubricating Oils' valued at \$62.3 million, and 'Strips of polysytrene' at \$42.9 million. The combined value of these commodities represented 14.5% of total imports (Table i).

In 2015, total exports (domestic and re-exports) totaled \$442.8 million showing a significant decline of 35.7% from 2014. The major contributor to the decline was the category of 'Mineral Fuels' (\$70.4million) for re-exports for 2015, which showed a significant decrease of 57.4% from 2014's total of \$165.3 million. The category of 'Chemicals' also showed significant decline from 2014's total of \$276.2 million compared to \$145.7million for 2015. Domestic exports (\$223.8 million) accounted for 50.5% of total exports. The main contributors to domestic exports were the categories of 'Chemicals' totaling \$135.5 million (60.5% of total domestic exports), 'Food and Live Animals' totaling \$62.1 million (27.7% of total domestic exports), and 'Crude Minerals' totaling \$24.8 million (11.1% of total domestic exports) (Table 2.3). Three commodities, 'expansible polystyrene' valued at \$83.7million, 'spiny lobster tail fresh, chilled and frozen' at \$56.2 million accounted for some 84% of total domestic exports 'other compounds containing a pyrimidine or piperazine ring' at \$49.0 million, and (Table ii).

The trade deficit decreased by 12.3% between 2014 and 2015 resulting in a negative trade balance of \$2.7 billion.

Main Trading Partners

While the United States (\$2.6 billion) maintained its position as The Bahamas' main trading partner representing 81.6% of total imports, there was a significant amount of trade as it relates to imports between The Bahamas and Dominica (\$47.1 million), which showed a substantial increase over 2014's \$3.3 million and Japan (\$35.8 million).

In terms of exports the United States (\$364.7 million), France (\$16.4 million), Finland (\$14.1 million) and Canada (\$5.5 million) were among the top partner countries, representing 82.3%,3.7%, 3.1% and 1.2% of total exports, respectively (**Table iii & iv**).

Trade between The Bahamas and CARICOM countries was minimal as the region represented only 2.4% of total imports and 1.5% of total exports. **Oil Products** imported from Dominica, valued at \$43.1 million, accounted for 56.5% of total imports from the region. In terms of exports, Barbados, St. Kitts and Nevis and Antigua and Barbuda combined represented 88.6% of CARICOM's total in 2015. **(Table 2.8)**



Value of Imports by Section of Commodity: 2015








