
QUARTERLY GROSS DOMESTIC PRODUCT

The National Accounts Section of the Department of Statistics is pleased to release its series of Quarterly Gross Domestic Product (QGDP), compiled by both the Production and Expenditure Approaches. This is the inaugural release of the Expenditure Approach Quarterly GDP numbers, while this the second release for the Quarterly Production Approach results. The Quarterly series includes nominal (current) and real (constant) Quarterly GDP for the period 1st Quarter 2015 to 4th Quarter 2019.

Quarterly National Accounts Development:

The National Accounts Section received technical assistance from the International Monetary Fund's Caribbean Regional Technical Assistance Centre (CARTAC) in the development of the quarterly GDP methodology. A variety of indicators and methodologies have been engaged in an effort to provide the best representative indicators for each Industry.

It is important to note that the annual GDP serves as the benchmark for the Quarterly GDP series.
